## Eligibility to file nominations for the post of Managing Committee

The following members would be eligible to contest elections for the Managing Committee of the BSAM

- 1. Any individual who has been a member for at least 6 months of the BSAM.
- 2. Any Billiards department member nominated by affiliated Club/Gymkhana who has been the member of the association. The affiliation should be at least two years old and the arrears regarding Annual Subscription should be fully paid at the time of filing nomination.

- 3. An individual can file nomination for a maximum of two posts for the Managing Committee. However, <u>by 6 pm 26<sup>th</sup> September 2019 (final date of withdrawal)</u> he/she should withdraw from one post. Final elections have to be contested for one post only. Any person filing nomination for two posts and failing to withdraw from one before <u>26<sup>th</sup> September 2019</u> would be disqualified from the elections.
- All nominations must be received on or before <u>19<sup>th</sup> September 2019, by 6:00 pm</u> at the BSAM office. The final date for withdrawing the nomination is <u>26<sup>th</sup> September</u> <u>2019 by 6:00 pm</u>.

All members interested in standing for the elections must collect the form personally from the office after producing proper identification of their membership or can send a request for the Nomination form which will be sent via email. If any person is nominated from a Club/Gymkhana he/she must carry the nomination letter on the official letterhead from the President / Hon. Secretary of the institution clearly stating the post for which they are nominated.
