Eligibility to file nominations for the post of Managing Committee

1. The following members would be eligible to contest elections for the Managing Committee of the BSAM

- Any individual who has been a member for at least 6 months of the BSAM.
- Any Billiards department member nominated by a Club/Gymkhana which is a member of the association. The membership should be at least two years old and the arrears regarding Annual Subscription should be fully paid at the time of filing nomination.

Any person nominated from a Club/Gymkhana must submit their nomination form along with a letter on the club's official letterhead signed by the President / Hon. Secretary of the institution clearly stating the post for which they are standing. The above letter should be submitted along with the nomination form.

2. The Schedule for the elections is as under .

Nomination forms will be issued from : **12th to 17th September 2025**

Last Date of receiving forms : **22nd September 2025**

Last Date for Withdrawal : **24th September 2025**


Elections to be held on : **28th September 2025 (after AGM)**

Kindly note that the Office timing is from 11 am to 6 pm

3. An individual can file nomination for a maximum of two posts for the Managing Committee. However, by 6pm 24th September 2025 (final date of withdrawal) he/she should withdraw from one post. Final elections have to be contested for one post only. Any person filing nomination for two posts and failing to withdraw from one post on or before 6pm 24th September 2025 would be disqualified from both the posts and shall not be eligible to contest the elections.
