



Guidelines to Host a Tournament under the Aegis of BSAM

Procedure to apply for a tournament:

1. Host club must ensure that all its dues to BSAM are clear (paid to date).
2. An email from the host club giving details of the proposed:
 - Dates
 - Format (Open or Invitation or Handicap or a combination)
 - Prize Money
 - Sponsors details (if any)
 - Entry Fee
3. Upon receipt of the email; BSAM will review the above information and revert on the above pointers along with the Capitation Fee.
4. Upon agreement of the above details and after receiving the Capitation Fee by cheque; BSAM will then formalise the same by blocking the dates & upload the necessary information on its website.
5. And in order for the said tournament to be conducted under the aegis of BSAM, its stipulated Regulations must be followed.

Regulations of BSAM:

1. The Tournament must follow/fulfil each & every Resolution/Guideline of BSAM.
2. The Tournament Committee must include a minimum of two BSAM MC members. Preferably one of them should be an office bearer.
3. Only BSAM Registered Players will be allowed to participate in its events

PLEASE NOTE PLAYERS OF MAHARASHTRA DOMICILE HAVE TO PAY 500/- PER ANNUM AND NON DOMICLIE PLAYERS HAVE TO PAY ACCREDITATION FEES OF 300/- WHICH IS VALID FOR 6 MONTHS FROM DATE OF RECEIPT.

THE HOST WILL BE RESPOSIBLE TO COLLECT THE ABOVE AND DEPOSIT IT WITH BSAM , IF NOT THE AMOUNT WILL BE DEBITED TO THE HOST.

4. Only BSAM Registered Referees will be allowed to officiate in its events.
5. In case of Wild Cards or Direct Entries, it is advised that the Host should inform BSAM on the same before making commitments to players. As per the Regulations of BSAM, it is mandatory for the Host to incorporate Maharashtra No 1 & 2 (Seniors & Juniors) of that discipline in the tournament. THE HOST HAS 1 WILD CARD ENTRY IF THEY ARE SEEDING 8 PLAYERS AND 2 WILD CARDS IF 16 OR MORE PLAYERS ARE BEING SEEDED IN MAIN DRAW/DIRECT ENTRIES AND /OR INVITATING PLAYERS. ALL SEEDINGS WILL BE GIVEN ONLY ON BASIS OF CURRENT NATIONAL AND/OR MAHARASHTRA STATE RANKING.
6. There are a couple of more (minuted) regulations & will be shared when applicable.
7. All communication material developed such as posters, banners, widgets, reels, promos, videos will have to be approved by BSAM before they released in the public
8. All communication will only be done in writing and will only be counted as official once received from the club official email ID and duly signed by the authorized signatory.
9. Any non compliance of any of the regulations will automatically lead to cancellation of the tournament.
10. The Host Club must send an Undertaking on the clubs letterhead to abide by all the regulations laid down in the Guideline document “ Host a Tournament “
